TÉRMINOS Y CONDICIONES DEL COMPRADOR

Tenga en cuenta que estos Términos y condiciones se aplican a los siguientes eventos:

CoCoA H2H Travel Market Ibero-America Series (27-30 October 2025; 14-17 January 2026; 25-28 February 2026; 8-11 April 2026; 26-29 October 2026).

1. DEFINICIONES En estos Términos y Condiciones, las siguientes palabras tendrán los siguientes significados a menos que el contexto requiera lo contrario:

1.1 "CoCoA H2H Ibero-America Travel Market" significa eventos presenciales dirigidos por citas realizados entre compradores y proveedores en diferentes ubicaciones en 2024.

1.2 "Equipo del Travel Market de CoCoA H2H Ibero-America " significa los empleados de CoCoA H2H o partes externas designadas.

1.3 "Evento" significa uno o más de los eventos enumerados en la tabla anterior o cualquier otro evento operado por CoCoA H2H.

1.4 "Comprador alojado" significa la persona, aceptada por CoCoA H2H, que asistirá al Evento como comprador de productos de viaje de alta gama donde CoCoA H2H proporciona alojamiento, traslados, comidas y experiencias de cortesía.

1.5 "Sistema de Citas Preprogramadas" significa el sistema de citas operado por CoCoA H2H Ibero-America Travel Market para coordinar las citas de los Hosted Buyers y proveedores de CoCoA H2H Ibero-America Travel Market durante el Evento.

1.6 "Proveedores" significa proveedores de alto nivel que han contratado con CoCoA H2H para participar en los Eventos de CoCoA H2H Ibero-America Travel Market.

1.7 "CoCoA H2H" significará CoCoA H2H SL o cualquier empresa u organización asociada, matriz o subsidiaria.

2. CONDUCTA DE LOS COMPRADORES ALOJADOS

2.1 Si su solicitud para unirse al Evento tiene éxito, los "Compradores Hospedados" recibirán de CoCoA H2H:

2.1.a Hasta tres noches de alojamiento incluyendo desayuno, almuerzo y cena, pero excluyendo todos los extras que incluyen servicio a la habitación, llamadas telefónicas y bebidas en la habitación (que correrán a cargo del Hosted Buyer) por evento

2.1.b Traslados de regreso al aeropuerto al hotel anfitrión en el destino donde se llevará a cabo el Evento, solo en las fechas de llegada y salida según lo establecido en la agenda oficial del evento proporcionada por el equipo de CoCoA H2H Ibero-America Travel Market y solo al recibir los vuelos. Información no menos de dos semanas antes del evento.

2.1.c Ingreso al correspondiente Travel Market CoCoA H2H Ibero-America (programa completo)

2.1.d Citas programadas previamente en los días de networking del Evento

2.1.e Entrada a todas las comidas oficiales, fiestas y eventos de networking organizados por CoCoA H2H Ibero-America Travel Market en relación al Evento.

2.2 Como condición para recibir los servicios anteriores, siendo aquellos servicios y beneficios establecidos en la cláusula

2.1, desde CoCoA H2H Ibero-America Travel Market, los "Hosted Buyers" estarán obligados a:

2.2.a Participar activamente en todo el Programa de Citas Preprogramadas, es decir, seleccionando a todos los expositores en orden de preferencia de citas dentro de un período de tiempo específico.

2.2.b Asistir a todas las reuniones y sesiones de networking programadas por el Equipo de CoCoA H2H Ibero-America Travel Market e incluidas por el Equipo de CoCoA H2H Ibero-America Travel Market en sus agendas

2.2.c Llevar vestimenta informal elegante adecuada como condición de entrada y participación durante el Evento. 2.2.d Llegue al Evento a más tardar a las 11 p.m. del Día de Llegada establecido por el Equipo de CoCoA H2H Ibero-America Travel Market y según el cronograma del Evento.

2.3. El incumplimiento por parte de cualquier persona de los requisitos establecidos anteriormente puede resultar en una revisión del estado de Comprador Hospedado de la persona y/o exclusión del Programa de Comprador Hospedado de Eventos y futuros Programas de Comprador Hospedado de CoCoA H2H Ibero-America Travel Market sin reembolso de cualquier suma que pueda ya han sido pagados por esa persona. Un déficit significativo por parte del Comprador invitado en el compromiso mínimo con respecto a la asistencia a las citas será tratado por el equipo de CoCoA H2H Ibero-America Travel Market como una cancelación, y se aplicarán tarifas de cancelación (consulte la sección "Cancelaciones" a continuación). La asistencia a lo anterior será monitoreada in situ por el equipo de CoCoA H2H Ibero-America Travel Market.

3. COVID-19

3.1 CoCoA H2H Ibero-America Travel Market se toma en serio la salud y seguridad de Hosted Buyers y nuestros proveedores. A la luz de la pandemia de COVID-19, el Comprador invitado no debe asistir al Evento si él o alguien con quien vive muestra alguno de los siguientes síntomas:

3.1.a Una temperatura de 37,8°C o superior;

3.1.b Nueva tos seca continua; o

3.1.c Pérdida o cambio en el sentido normal del olfato o del gusto.

3.2 CoCoA H2H Ibero-America Travel Market se reserva el derecho de negar la entrada a cualquier persona que presente síntomas de COVID 19.

3.3 Además de los requisitos establecidos en la cláusula 3.2 anterior, CoCoA H2H Ibero-America Travel Market podrá exigir a los Hosted Buyers que:

3.3.a Proporcionar prueba de una prueba de flujo lateral negativa para COVID-19 realizada dentro de las 48 horas anteriores a la llegada al Evento; o

3.3.b Realizar una prueba de flujo lateral para COVID-19 al llegar al Evento que muestre un resultado negativo para COVID-19; o

3.3.c Proporcionar prueba de vacunación COVID-19 a satisfacción razonable de CoCoA H2H Ibero-America Travel Market.

3.4 CoCoA H2H Ibero-America Travel Market se reserva el derecho de negar la admisión a cualquier Hosted Buyer que no cumpla uno de los requisitos establecidos en la cláusula 3.3. CoCoA H2H Ibero-America Travel Market se reserva además el derecho de exigir que un Comprador invitado realice una prueba de flujo lateral de COVID-19 independientemente de si ha sido vacunado contra el COVID-19 inmediatamente antes del comienzo del Evento.

3.5 Antes de llegar al Evento, el Comprador Invitado deberá familiarizarse y cumplir con la política de salud y seguridad de CoCoA H2H Ibero-America Travel Market según lo dispuesto para el Evento. El Comprador Hospedado acepta que esta es una obligación continua que se extiende a cualquier política, procedimiento o medida adicional que CoCoA H2H Ibero-America Travel Market pueda implementar de vez en cuando con respecto a su respuesta al COVID-19 y que se proporcionen al Comprador alojado por escrito.

3.6 El Comprador invitado reconoce incondicionalmente que existe un elemento de riesgo de exposición al COVID-19 asociado con cualquier forma de participación en una actividad que involucre a otras personas que trabajan relativamente cerca. Si bien CoCoA H2H Ibero-America Travel Market se adherirá a los protocolos de salud y seguridad y seguirá todas las recomendaciones de evaluación de riesgos para minimizar el riesgo de exposición al COVID-19, Hosted Buyer reconoce que existe la posibilidad de que los Representantes entren en contacto directo o indirecto con COVID-19 y acepta libre y voluntariamente participar en el Evento con este conocimiento.

4. VIAJE Y ALOJAMIENTO

4.1 Los Compradores invitados proporcionarán los detalles de su viaje al equipo de CoCoA H2H Ibero-America Travel Market a más tardar dos semanas antes de las fechas del Evento. Dichos compradores invitados están obligados a llegar al evento antes de las 11:00 p. m. del día de llegada y a partir no antes de las 22:30 p. m. del día de salida.

4.2 CoCoA H2H Ibero-America Travel Market proporcionará al Comprador invitado un traslado de regreso desde el aeropuerto designado por el equipo de CoCoA H2H Ibero-America Travel Market hasta el hotel anfitrión. En caso de que haya más de un aeropuerto en el destino donde se celebrará el Evento, consulte con el equipo de CoCoA H2H Ibero-America Travel Market a dónde debería volar. Los traslados se realizarán en coche o minibús. Los traslados se organizarán no antes del día de llegada. Los traslados de regreso se organizarán únicamente el día de salida.

4.3 CoCoA H2H Ibero-America Travel Market proporcionará al Comprador Hospedado un máximo de tres noches de alojamiento en el hotel anfitrión y durante las fechas del Evento únicamente de acuerdo con la subcláusula 2.1.a.

4.4 CoCoA H2H Ibero-America Travel Market no será responsable de los costos adicionales de habitación incurridos durante la estadía. Cualquier mejora de habitación quedará únicamente a discreción de la dirección del hotel. Las noches adicionales, si las solicita el Hosted Buyer, las pagará localmente directamente al hotel.

5. CANCELACIÓN Y SUSTITUCIONES PARA COMPRADORES ALOJADOS

5.1 Reemplazos: Las invitaciones a Hosted Buyers no son transferibles. En los casos en los que los Hosted Buyers necesiten cancelar su participación, deben solicitar y reemplazar de inmediato su asistencia con un colega senior de su organización para que asista como reemplazo. Con la condición de que el reemplazo sea aceptado por el equipo de CoCoA H2H Ibero-America Travel Market, no se aplicará un cargo por cancelación/cambio. Si no se puede encontrar al sustituto y si el colega superior reemplazado también cancela su participación, se aplicará la cláusula 4.2.

5.2 Cancelación de asistencia: Si bien no se recomienda, los Hosted Buyers pueden cancelar su asistencia al Evento sin penalización hasta 45 días antes de la fecha de inicio indicada del evento. Las cancelaciones recibidas a partir de 45 días antes de la fecha de inicio del evento incurrirán en una tarifa de 500 EUR. Tenga en cuenta que un miembro del equipo de CoCoA H2H Ibero-America Travel Market se pondrá en contacto con una factura individual de acuerdo a sus costos. Usted será responsable de pagar lo siguiente:

5.2.1. Cargo por cancelación de alojamiento o equivalente de alojamiento de la estadía dependiendo del momento de la cancelación y de acuerdo con la política del hotel anfitrión.

5.2.2. Traslado de llegada

5.2.3. Traslado de salida

5.2.4. Costo de traslados durante el evento

5.2.5. Costos de comidas (almuerzos, pausas para el café, cócteles o cenas)

5.2.6. Costo de las experiencias individuales (puede variar dependiendo de cuántas reuniones)

5.2.7. Honorarios de proveedores por reuniones perdidas 5.2.8. Costos posteriores al viaje familiar (si corresponde)

5.3 Todas las cancelaciones deben ser recibidas por el equipo de CoCoA H2H Ibero-America Travel Market por escrito y deben haber sido reconocidas en las fechas especificadas anteriormente por el equipo de CoCoA H2H Ibero-America Travel Market.

5.4 Un déficit significativo por parte de los Hosted Buyers en sus compromisos mínimos con respecto a la asistencia a las citas será tratado por el equipo de CoCoA H2H Ibero-America Travel Market como una cancelación de asistencia y los Hosted Buyers incurrirán en una tarifa de cancelación de GBP £1,500 incluido el IVA.

5.5 No presentarse: los compradores invitados que no informen al equipo de CoCoA H2H Ibero-America Travel Market de sus cancelaciones 45 días antes de la fecha del evento y no asistan al evento especificado de CoCoA H2H Ibero-America Travel Market incurrirán en una tarifa de no presentación de EUR. 500€ IVA incluido.

5.6 Hosted Buyers deberá pagar las tarifas de cancelación de asistencia y cualquier tarifa de no presentación dentro de los treinta días posteriores a la recepción de la factura de cancelación o no presentación. CoCoA H2H Ibero-America Travel Market proporcionará al Comprador invitado un recibo con respecto a la cancelación de las tarifas de asistencia y las tarifas por no presentarse. El Hosted Buyer puede solicitar una factura si es necesario.

5.7 CoCoA H2H Ibero-America Travel Market tendrá derecho a cancelar el lugar del Hosted Buyer y retirar o cancelar todos los beneficios si considera, a su exclusivo criterio, que los productos o servicios proporcionados por el Hosted Buyer o cualquier persona que asista al evento con el Hosted Buyer mencionado al dorso, no se ajustan al perfil del Evento.

5.8 Los Hosted Buyers aceptan que los cargos anteriores son una estimación previa razonable de la pérdida sufrida por CoCoA H2H Ibero-America Travel Market en caso de que los Hosted Buyers incumplan estos Términos y condiciones o cancelen su asistencia.

5.9 Los Compradores invitados que asistan al Evento pero se les niegue la entrada debido al incumplimiento de las medidas COVID19 establecidas en la cláusula 3.3 no incurrirán en ningún cargo de cancelación.

6. EXCLUSIÓN DE RESPONSABILIDAD

6.1 CoCoA H2H Ibero-America Travel Market no asume ninguna responsabilidad (incluidos los costos incurridos)

6.1.1. para Hosted Buyers que pierden su vuelo;

6.1.2. por la insolvencia o quiebra de cualquier compañía aérea, hotel o empresa de asistencia en tierra u otro proveedor;

6.1.3. por cancelación o retraso de vuelo;

6.1.4. si a un Comprador invitado se le niega el permiso para abordar la aeronave o se le niega la entrada al destino donde se celebra el Evento por cualquier motivo;

6.1.5. por cualquier retraso o pérdida de equipaje o cargos por exceso de equipaje: cualquier disputa posterior se realizará directamente entre el Comprador alojado y la aerolínea correspondiente; o

6.1.6. por cualquier costo incurrido como resultado de que al Comprador Invitado se le haya negado la entrada al Evento.

6.2 Los Hosted Buyers deben obtener una cobertura de seguro de viaje adecuada para su estadía y se recomienda en particular que contraten un seguro de cancelación adecuado para cubrir los casos mencionados en el párrafo 5.1, un seguro para su equipaje y un seguro médico compatible con COVID19.

6.3 Los requisitos de visa individual, permisos de viaje, otras licencias y vacunas serán responsabilidad exclusiva del Comprador alojado, incluidos los costos necesarios incurridos.

6.4 CoCoA H2H Ibero-America Travel Market, sus agentes, sus empleados y sus subcontratistas no serán responsables por pérdidas, daños o retrasos resultantes de actos o amenazas de guerra, secuestros, actividades terroristas, conmoción civil, disputas industriales, escasez de combustible, desastres naturales, desastres o condiciones climáticas adversas, huelgas o cierres patronales, intervención o regulación, actividad militar, epidemias, pandemias incluso en relación con el Coronavirus y COVID-19 o cualquier otra circunstancia fuera del control de CoCoA H2H Ibero-America Travel Market o de sus subcontratistas que lo haga imposible o desaconsejable para que CoCoA H2H Ibero-America Travel Market celebre el Evento en el momento y lugar previstos o haga imposible llevar a los Hosted Buyers al Evento o para proporcionar vuelos, hoteles, citas de traslado, eventos u otros servicios a los Hosted Buyers

6.5 CoCoA H2H Ibero-America Travel Market se reserva el derecho de reprogramar el Evento en otra fecha y/o en un sitio alternativo, ya sea como consecuencia de un evento de Fuerza Mayor o de otro modo. En caso de que el Evento no se lleve a cabo y sea cancelado por cualquier motivo, el Hosted Buyer acepta y reconoce que está obligado a asistir al Evento virtual que CoCoA H2H Ibero-America Travel Market procurará realizar en las fechas del Evento original.

6.6 CoCoA H2H Ibero-America Travel Market no será responsable ante el Comprador Hospedado, por contrato, agravio o de otro modo, por cualquier pérdida de ganancias, pérdida de negocios o ingresos, pérdida de ahorros anticipados o cualquier pérdida o daño, costos o gastos indirectos o consecuentes. que surjan de o en conexión con la asistencia de Hosted Buyers al Evento.

6.7 CoCoA H2H Ibero-America Travel Market no será responsable de la muerte o lesiones personales de ningún Comprador Hospedado, salvo que dicha responsabilidad no pueda excluirse según la legislación española.

6.8 La responsabilidad de CoCoA H2H Ibero-America Travel Market hacia un Comprador Invitado con respecto a su asistencia al Evento bajo estos Términos y Condiciones, ya sea por contrato, agravio o de otro modo, no excederá los 500 EUR.

7. GENERALIDADES

por cada participante propuesto y solo se aceptará el primer formulario de solicitud. Los solicitantes deben ser mayores de dieciocho años.

7.2 Los solicitantes seleccionados solo serán aceptados como Hosted Buyers si completaron completamente el formulario de solicitud, leyeron y aceptaron estos Términos y condiciones y confirmaron su aceptación marcando las casillas correspondientes en el formulario de solicitud en línea.

7.3 El equipo de CoCoA H2H Ibero-America Travel Market se reserva el derecho de eliminar a un Hosted Buyer del Programa de Hosted Buyer a su entera discreción y sin responsabilidad si el equipo de CoCoA H2H Ibero-America Travel Market lo considera que es lo mejor para CoCoA H2H Ibero-America Travel Market. Please note these Terms and Conditions apply to the events below:

CoCoA H2H Ibero-America Travel Market Series (27-30 October 2025; 14-17 January 2026; 25-28 February 2026; 8-11 April 2026; 26-29 October 2026).

1. DEFINITIONS In these Terms and Conditions, the following words shall have the following meanings unless the context otherwise requires:

1.1 " CoCoA H2H Ibero-America Travel Market" means face to face appointment led events held between buyers and suppliers in different locations.

1.2 " CoCoA H2H Ibero-America Travel Market Team" means the employees of CoCoA H2H or appointed outside parties.

1.3 "Event" means one or more of the events listed in the table above or any other event operated by CoCoA H2H.

1.4 "Hosted Buyer" means the person, accepted by CoCoA H2H, who will attend the Event as a buyer of high-end travel products where complimentary accommodation, transfers, meals and experiences are provided by CoCoA H2H.

1.5 "Pre-Scheduled Appointment System" means the appointment system operated by CoCoA H2H Ibero-America Travel Market to co- ordinate the appointments of the Hosted Buyers and CoCoA H2H Ibero-America Travel Market suppliers during the Event.

1.6 "Suppliers" mean high-end suppliers who have contracted with CoCoA H2H to participate at CoCoA H2H Ibero-America Travel Market Events.

1.7 "CoCoA H2H" shall mean CoCoA H2H SL or any associated, parent or subsidiary company or organisation.

2. CONDUCT OF HOSTED BUYERS

2.1 Should their application to join the Event be successful, "Hosted Buyers" will receive from CoCoA H2H:

2.1.a Up to three nights' accommodation including breakfast, lunch and dinner, but excluding all extras including room service, telephone calls and in-room drinks (which are to be borne by the Hosted Buyer) per event

2.1.b Return airport transfers to the host hotel in the destination where the Event is being held, only on the arrival and departure dates as outlined in the official event agenda provided by the CoCoA H2H Ibero-America Travel Market Team and only upon receipt of flights information no less than two weeks prior to the event

2.1.c Entry to the relevant CoCoA H2H Ibero-America Travel Market (full programme)

2.1.d Pre-scheduled appointments on the Event networking days

2.1.e Entry to all official meals, parties and networking events organized by CoCoA H2H Ibero-America Travel Market in relation to the Event.

2.2 As a condition of receiving the above services, being those services and benefits set out in clause 2.1 from CoCoA H2H Ibero-America Travel Market, "Hosted Buyers" will be required to:

2.2.a Actively participate in all the Pre-Scheduled Appointments Programme, i.e. selecting all the exhibitors in order of appointment preferences within a specified timeframe.

2.2.b Attend all meetings and networking sessions scheduled by the CoCoA H2H Ibero-America Travel Market Team and included by the CoCoA H2H Ibero-America Travel Market Team in their diaries

2.2.c Wear suitable smart casual attire as a condition of entry to and participation during the Event.

2.2.d Arrive at the Event no later than 11pm on the Arrival Day set by the CoCoA H2H Ibero-America Travel Market Team and as per Event schedule.

2.3. Failure by any person to comply with the requirements stated above may result in a review of the person's Hosted Buyer status and / or exclusion from the Event Hosted Buyer Programme and future CoCoA H2H Ibero-America Travel Market Hosted Buyer Programmes without refund of any sums that may have already been paid by that person. A significant shortfall by the Hosted Buyer on the minimum commitment with respect to attending appointments shall be treated by the CoCoA H2H Ibero-America Travel Market Team as a cancellation, and cancellation fees will apply (see "Cancellations" section below). Attendance at the above will be monitored on site by the CoCoA H2H Ibero-America Travel Market Team.

3. COVID-19

3.1 CoCoA H2H Ibero-America Travel Market takes the health and safety of Hosted Buyers and our suppliers seriously. In light of the COVID-19 pandemic the Hosted Buyer must not attend the Event if they or someone they live with is displaying any of the following symptoms:

3.1.a A temperature of 37.8C or greater;

3.1.b A new dry continuous cough; or

3.1.c A loss of, or change in, normal sense of smell or taste.

3.2 CoCoA H2H Ibero-America Travel Market reserves the right to refuse entry to any person displaying symptoms of COVID 19.

3.3 In addition to the requirements set out in clause 3.2 above, CoCoA H2H Ibero-America Travel Market may require Hosted Buyers to:

3.3.a Provide proof of a negative Lateral Flow Test for COVID-19 taken within 48 hours prior to arrival at the Event; or

3.3.b Undertake a Lateral Flow Test for COVID-19 upon arrival at the Event which shows a negative result for COVID-19; or

3.3.c Provide proof of COVID-19 vaccination to the reasonable satisfaction of CoCoA H2H Ibero-America Travel Market.

3.4 CoCoA H2H Ibero-America Travel Market reserves the right to refuse admission to any Hosted Buyer who does not meet one of the requirements set out in clause 3.3. CoCoA H2H Ibero-America Travel Market further reserves the right to require a Hosted Buyer to undertake a COVID-19 Lateral Flow Test regardless of whether they have been vaccinated against COVID-19 immediately prior to the commencement of the Event.

3.5 Prior to arrival at the Event, the Hosted Buyer shall familiarise themselves with and comply with CoCoA H2H Ibero-America Travel Market's health and safety policy as provided for the Event. The Hosted Buyer agrees that this is an ongoing obligation that extends to any additional policies, procedures or measures that CoCoA H2H Ibero-America Travel Market

may put in place from time to time in respect of its response to COVID-19 and which are provided to the Hosted Buyer in writing.

3.6 The Hosted Buyer unconditionally acknowledges that there is an element of risk of exposure to COVID-19 associated with any form of participation in an activity involving other individuals working at relatively close proximity. While CoCoA H2H Ibero-America Travel Market shall adhere to the health and safety protocols and follow all risk assessment recommendations to minimise the risk of exposure to COVID-19, Hosted Buyer acknowledges that there remains a possibility that the Representatives may come into direct or indirect contact with COVID-19 and freely and willingly agrees to participate in the Event in this knowledge.

4. TRAVEL AND ACCOMMODATION

- "Confidential Information" means, with respect to each party to this Agreement, all information (whether oral, written, graphic, machine-readable, or in sample form) of a confidential or proprietary nature, whether or not marked as "Confidential" or "Proprietary" or with a similar designation, owned, developed, controlled, licensed, acquired, or used by that party (whether or not related to this Agreement) and relating to its business;

- "Event" shall mean the event set out in the Programme;

- "Event Date(s)" shall mean the date or dates of the Event as set out in the Programme or any other date on which the Event is held in accordance with this Agreement;

- "Event Venue" shall mean the venue shown in the Programme or any other venue at which the Event is held in accordance with this Agreement;

- "Force Majeure" shall mean any circumstance beyond the reasonable control of Content Cocktails LTD (CoCoA H2H) , including, without limitation, war, acts of terrorism, riots, civil commotion, strikes, lockouts, or other industrial action, natural disasters, storms, fire, earthquakes, floods, power failure, or action by a government or other competent authority;

- (b) an order is made for the liquidation of the other party;
- (c) an effective resolution is passed for the liquidation of the other party (other than for the purposes of merger or reconstruction on terms approved by the first party);

Each party agrees and undertakes to keep all Confidential Information strictly confidential and not to disclose it in whole or in part at any time to any third party, nor to use the Confidential Information for any purpose other than the fulfilment of its obligations under this Agreement. This provision shall survive the termination of this Agreement for any reason for a period of 2 (two) years from the date of such termination.

6.2 Confidential Information shall not include information that:

- (a) at the time of disclosure or prior to it, was known to the receiving party or was publicly available as evidenced in writing, except to the extent that such information was unlawfully appropriated;
- (b) at the time of disclosure or thereafter, becomes publicly available, except through any act or omission by the receiving party;
- (c) is received from a third party free to make such disclosure without breaching any legal obligation;
- (d) is independently developed by the receiving party; or
- (e) must be disclosed by law, court order, or request from any governmental or regulatory authority.

7. LIABILITY

7.1 Nothing in this Agreement shall exclude or restrict the liability of either party for death or personal injury resulting from its negligence.

7.3 Neither party shall be liable to the other under contract, tort, breach of statutory duty, or otherwise in connection with any matter arising directly or indirectly from or related to this Agreement for any indirect, consequential, incidental, or punitive loss or damage or liability, including consequential or incidental loss of profits, business, data, or the use of data.

7.4 Neither party shall be liable for any loss or failure to fulfil its obligations under this Agreement due to circumstances beyond its reasonable control.

8. GENERAL

8.1 This Agreement relates solely to the Event referred to in this Agreement.

8.2 This Agreement constitutes the entire understanding between the parties regarding its subject matter and supersedes all prior communications, representations, arrangements, understandings, and agreements, whether written or oral, relating to it. No variation or amendment to this Agreement shall be effective unless made in writing and signed on behalf of each party to this Agreement. Nothing in this Agreement shall be construed as creating a partnership, joint venture, or employment relationship between the parties.

8.3 If any provision of this Agreement is found to be void, invalid, or unenforceable for any reason, such invalidity or unenforceability shall not affect the validity of the remaining provisions of this Agreement, and the provisions declared void or invalid shall be deemed to have been removed from this Agreement.

8.4 This Agreement shall be governed by and construed in accordance with the laws of Spain.

8.5 Any notice given by either party under this Agreement shall be delivered in writing to the recipient at its address set out above (or such other address as that party may notify to the other for the purposes of this Agreement). Any such notice shall be deemed delivered if sent by first-class post, 48 (forty-eight) hours after posting; and, if sent by fax, at the time of transmission, confirmed by a transmission report from the sender's fax machine.

8.6 The parties to this Agreement do not intend that any of its terms shall be enforceable under the Contracts (Rights of Third Parties) Act applicable in Spain.

8.7 This Agreement may not be assigned or otherwise transferred in whole or in part by either party without the prior written consent of the other, except that either party may assign its rights and obligations under this Agreement to a Group Company without requiring consent.

EVENT POLICY

1. Introduction

CoCoA H2H Ibero-America Travel Market (“us”, “our”, “we”, “CoCoA H2H”) is the controller of your personal data collected when you register for and attend CoCoA H2H Ibero-America Travel Market (the “Event”). 3. How is your personal data collected?

We share this personal data with the Caterer to ensure the food and drink you receive meets those requirements. This information may contain personal data about your health or your religious beliefs. Sharing that personal data with the Caterer is (i) in our legitimate interest so that we can provide you with food and drink during the Event and (ii) is in your vital interest to protect your safety (and even your life) and/or respect your religious and philosophical beliefs.

5. How and why do we use your personal data?

Lawful basis for processing your personal data

We will only use your personal data when the law allows us to. Most commonly we will use your personal data in the following circumstances:

- Where we need to do so in order to perform a contract we have entered into with you;
- Where it is necessary for our legitimate interests (or those of a third party) and your fundamental rights do not override those interests;
- Where you have asked us to do so, or consented to us doing so; and
- Where we need to comply with a legal or regulatory obligation.

Here are some examples about how we may use the personal data we collect about you and the lawful basis we rely on to do so.

Identity and profile data (including your name, food allergy information and dietary requirements).	Legitimate interest (to supply you with food and drink you would like to consume). Vital interest to protect your right to life and/or religious and philosophical beliefs.

To take and create promotional materials at the Event (such as taking photographs and videos of you at the Event).	Identity data (including your image).	Legitimate interest (to grow our business and inform our marketing strategy).
To interview you at the Event.	Identity and profile data (including your image and responses to any questions asked during the interview)	Consent
To process and deliver payment for the Event including: (a) Manage payments, fees and charges. (b) Collect and recover money owed to us.	Identity, contact, financial and transaction data.	Performance of our contract with you. Necessary for our legitimate interest (to recover debts due to us).
To make suggestions and recommendations to you about other Events which may be of interest to you.	Identity, contact, profile and marketing and communications data.	Legitimate interest (to grow our business and inform our marketing strategy).

Marketing

We may use your personal data to form a view on what we think you may want or need, or what may be of interest to you. This is how we decide which events, services and offers may be relevant for you (we call this marketing).

You will receive marketing communications from us if you have requested certain information from us about the Event or have registered to attend the Event and you have not opted out of receiving that marketing.

We will get your express opt-in consent before we share your personal data with any third party for marketing purposes.
